



PROVINCE OF KWAZULU-NATAL BOOKMAKERS' TAX RETURN

In terms of section 129 (1) of the KwaZulu-Natal Gaming and Betting Act, 2010 –

Every Bookmaker licensee must, within ten days after the end of the month pay to the Board all monies that were deducted from bettors in terms of section 128(1) and the betting taxes and deductions determined in terms of the KwaZulu-Natal Gaming and Betting Tax Act, 2010; and lodge with the Board tax returns in the form determined in terms of section 7(2)(k).
