



## **APPLICATION FOR ANNUAL RENEWAL OF LICENCE: RACECOURSE OPERATOR**

### **Section 39 of the KwaZulu-Natal Gaming and Betting Act No 08 of 2010**

- (1) *A licence, subject to the provision of this Act and the conditions under which it was granted, remains in force until the date of renewal or, in the case of a temporary licence, the date of expiry.*
- (2) *It is the responsibility of the licensee to apply to the Board for the renewal of a licence and to pay licence fee prescribed in Schedule 2, at least 60 days prior to the date on which the licence becomes renewable.*
- (3) *If a licensee fails to renew his or her licence by the date of renewal, the licence lapses and the licensee must –*
  - (a) *Cease the activities authorised by the licence; and*
  - (b) *If he or she so wishes, apply to the Board for a new licence in accordance with the provisions of section 30, in which event all the provision of this Act relating to an application for a licence apply, with the necessary changes.*
