Section 111 of the KwaZulu-Natal Gaming and Betting Act No 08 of 2010

- (4) The registration of a totalisator manager or totalisator agent is valid for a period of 12 months commencing from the date of issue until the last day of the anniversary of the month of issue, but may be renewed from year to year in the discretion of the Board.
- (5) The fees payable on application for registration or renewal contemplated in this section are as prescribed Schedule 2 and are payable to the Board.
