

APPLICATION FOR ANNUAL RENEWAL OF REGISTRATION: TOTALISATOR OPERATOR

Section 111 of the KwaZulu-Natal Gaming and Betting Act No 08 of 2010

- (4) The registration of a totalisator operator is valid for a period of 12 months commencing from the date of issue until the last day of the anniversary of the month of issue, but may be renewed from year to year in the discretion of the Board.
- (5) The fees payable on application for registration or renewal contemplated in this section are as prescribed I Schedule 2 and are payable to the Board.

"Totalisator Operator" means a natural person appointed by a totalisator licensee in terms of section 111(1)(a) and who is in charge of and responsible for the day to day conduct and operation of the relevant totalisator: Provided that, for the purposes of this definition, "person" can include a board, committee or other similar group of persons."
