All licensees are hereby advised that the KZN Gaming and Betting Board will be abiding by the statement that was made by the President of South Africa on 23 March 2020, in respect of a Nationwide-Lockdown The KZN Gaming and Betting Board offices located in Pietermaritzburg and Durban will be closed from 25 March 2020 and will reopen as per the directive of the President.

## 2.1 Betting Licensees

The original signed copies may be delivered once the office has reopened. Licensees must continue to pay their taxes utilizing EFT payments.

## 2.2 Gaming Licensees

All Gaming Licenses are to continue utilizing the processes in place in respect of the submission of the gaming taxes and related payments. To that end, licensees must continue to pay their taxes. # 4. Closure of Gaming and Betting Industry outlets and establishments

In light of the recent legislative restrictions that have been implemented by the National Government in respect of the COVID-19 outbreak, the KZN Gaming and Betting industry must take into consideration the limitations in respect of the National Lockdown which will be in effect from 26 March 2020 (midnight) as directed by the President, which only permits the operation of essential infrastructure and related services.

In line with this requirement, the KZNGBB hereby requests all licensees to submit their lockdown plans by 10h00 on 26 March 2020 via email to Clarissa Naidoo: <a href="mailto:naidooc@kzngbb.org.za">naidooc@kzngbb.org.za</a>.

The KZNGBB Whistle-Blower Hotline will be operational, to that end the public will be able to report the details of any outlets and establishments which remain open during the lockdown period.

#### **Extended Period of Closure**

Should a licensee wish to close an establishment or outlet for a period which is excess of the 21 Days Lockdown period, they must make an application to the Board, in respect of Section 40 (1) (d) of the KZN Gaming and Betting Act No.8 of 2010.
